Name	Subject
HSE	Response to residents that Bovis have been spoken to again in terms of lack of communication with residents. HOWEVER, HSE rule that this is a case for small Claims court (and not HSE) and residents should pursue this matter via the courts.
Gt Boughton PC	Enquiry as to whether any issue has been raised by Huntington PC about too many HGV Vehicles using Caldry Valley Rd. Clerk responds to say there has been no formal complaint in last 3 years.
2 more separate Resident Enquires	Concerns following visibility coming out of the following roads: Junction coming out of Sedum Close onto Gorse Way. Forwarded to Cllrs in Clerk Weekly update
5 Complaints (from Cllrs/Residents) plus many FB comments	Complaints regarding positioning of road closure/diversion signs at Gorse Way junction. Clerk emails CWaC who has them moved in the next morning.
Steve Lewis (Senior Planning Officer) and then follow-up from Resident	Steve Lewis assures PC that developers do intend to install the woodland path and includes latest plans. CWaC ask for photos to show that developers/homeowners have obstructed the proposed woodland path route with planting, fences etc. This is fed back to resident who originally raised the issue. Resident supplies photos and informs Clerk that CWaC already have the photos.
Resident (not of Huntington)	Member of public submits FOI request to ask if an email has been received containing his name and actions that the PC took.
Resident plus Huntington Under 5's	Enquiring as to what will happen to the Butterbache Rd school site once school has moved. Clerk informs that this is decision of CWaC although we have given feedback on what residents would like. Decision lies with CWaC.
Huntington Under 5	Request to place banner at Jub Field to advertise childcare provision. (Non-profit organisation). Cllrs consulted and decision to be made at October PC meeting.
Resident	Complaint regarding overgrown school hedge adjacent to Meadows Lane. Clerk informs CWaC Streetcare team and Headteacher who also follows this up.
Huntington PTA	Confirmation that Huntington PTA will be running separate event to Parish Council for Christmas this year but may welcome opportunity to work with PC in future years
United Utilities	Approval for community funding agreed but now request meeting with Chairman to ensure money will be used responsibly.
